## LPSB APPROVES NEW SCHOOL ZONES STARTING IN FALL, 2017

At its regular board meeting on November 2, the LPSB approved a school rezoning plan to begin with the 2017-2018 school term.

The zoning plan has been in the works for nearly one year with multiple meetings held for teachers, parents, and students to express input for new school zones. Demographer Mike Hefner with GIS Services presented three zone maps. The board ultimately approved the third revision.

District staff suggested that rezoning will allow for changes at schools above and below capacity to better balance out the needs of students in the system.

The board also approved administrative rule changes that will impact the transfer of students to new zones. One substantial change involves students who will be high school juniors or seniors next year. These students will have the option of staying at their current school for an additional year.

## TRANSFER POLICIES TO CHANGE School rezoning, Southside High cited

LPAE has worked closely with district staff to develop transparent and open transfer policies under looming changes to schools as a result of redistricting.

As the process of opening Southside High kicks into full gear, teachers currently employed with the system will have an opportunity to apply for positions at the new site beginning in January. In addition, voluntary transfers for all teachers will continue with requests through March 1<sup>st</sup>.

Dr. Aguillard has pledged to work with HR to post all positions online for a set period of time for employees to view. In addition, employees will receive first preference for transfer before April 1st at which point the district looks towards university graduates and other districts for filling positions.

Another major change comes in the form of involuntary transfers that will feature a district-designed rubric consisting of **COMPASS score**, **tenure**, **certification**, **and seniority in the system**. HR has indicated that COMPASS will account for roughly 20% of determining transfers. The idea here is to deemphasize relatively close COMPASS scores and the perceived subjective nature of observations.

#### STAFF MAKES TAX PROPISITION SUGGESTIONS TO BOARD

CFO Billy Guidry made a presentation to LPSB at its 11/9/16 at the urging of Superintendent Donald Aguillard. The presentation focused on a possible option of a 30 year property tax that could generate up to \$500 million in funds for building maintenance and technology

Mr. Guidry's presentation focused on the issue of bonds and the cost facing taxpayers in the parish. If approved by voters in an election an additional \$37.50 in property taxes per year for a \$100,000 home and \$187.50 per year for a \$200,000 home.

The board received the report without vote or comment.

## NEA JOINS COMMUNITY IN CELEBRATING AMERICAN EDUCATION WEEK

The National Education Association was one of the creators and original sponsors of American Education Week.

Distressed that 25 percent of the country's World War I draftees were illiterate and 9 percent were physically unfit, representatives of the NEA and the American Legion met in 1919 to seek ways to generate public support for education.

The conventions of both organizations subsequently adopted resolutions of support for a national effort to raise public awareness of the importance of education. In 1921, the NEA Representative Assembly in Des Moines, Iowa, called for designation of one week each year to spotlight education. In its resolution, the NEA called for: "An educational week ... observed in all communities annually for the purpose of informing the public of the accomplishments and needs of the public schools and to secure the cooperation and support of the public in meeting those needs."

The first observance of American Education Week occurred December 4-10, 1921, with the NEA and American Legion as the cosponsors. A year later, the then U.S. Office of Education joined the effort as a cosponsor, and the PTA followed in 1938.

Other co-sponsors are the U.S. Department of Education and national organizations including the National PTA, the American Legion, the American Legion Auxiliary, the American Association of School Administrators, the National School Boards Association, the American Federation of Teachers, the American School Counselor Association, and the National School Public Relations Association
